3. GUEST SPEAKER

3.1. City of Columbus GreenSpot (David Celebrezze)

- 3.1.1. Columbus is ranked in the top 25 cities with the most Energy Star buildings. There are a whole host of programs and organizations that are working to improve the sustainability of the city.
- 3.1.2. The primary goals for the Sustainable Columbus initiative are to increase the number of participants in the GreenSpot Columbus, to reduce greenhouse gas emissions, to protect public green resources, and to reduce waste in the community.
- 3.1.3. GreenSpot is a program that encourages community members and businesses to adopt behaviors that will increase their sustainability as an individual or neighborhood. There is an online platform where you can track your participation and earn points. Points can be redeemed for rebates and free rewards. This program is also doing outreach to provide education to and recruit program members from the population of Ohio State students.

6. OFFICER REPORTS (as submitted in Delegate Meeting Packet)

6.1. President (Post.144)

- 6.1.1. On April 4th, CGS is participating in the "Out of the Darkness" walk to engage and support people affected by suicide. CGS is a well-being sponsor and contributed financially to this event. Additionally, CGS has a team that will walk together. Please join the CGS team by signing up even if you can't be there in person (the website will ask if you want to donate but there is no need unless you want to).
- 6.1.2. The start date for graduate assistantships has changed to earlier in the month of August so be aware of that and look for information from your grad studies chairs and program chairs.
- 6.1.3. Office of Academic Affairs has communicated that there are ongoing talks about creating an ombudsperson office rather than an individual position. They are looking into this possibility and benchmarking against other institutions. The current projected timeline for this office to be created is January 2021. Post.144 is looking into other ways that we can support student in the meantime.
- 6.1.4. The Parenting and Pregnant Student Working Group is continuously evaluating the current resources provided to students with families including childcare, food insecurity, and housing. This issue will be brought up in that group for further consideration, as well as a formal request will be sent to the Provost to form a committee that will comprehensively evaluate and produce a new proposal.
- 6.1.5. Post.144 will be sending out a year-end survey to evaluate progress CGS has made this year and establish priorities for next year.

6.2. Vice President (Bauman.193)

- 6.2.1. Senator elections are happening next month. Application materials will be included in the meeting packet. Candidates will not speak to the delegate body so make sure you look over materials ahead of the meeting and are prepared to vote.
- 6.2.2. Applications for open delegate positions will be accepted between March 23 and April 2. Voting will happen online.
- 6.2.3. Thank you to everyone who assisted and participated in the Hayes Forum. Feedback about this event will

be collected via an online survey.

6.3. Treasurer (Haynes.242)

- 6.3.1. Our official budget shows that we have over-spent for both the Ray and CDG. This is because of the way our current funding guidelines require that we overspend for recipients who do not plan to use the maximum amount of the award. This will even out at the end of the year.
- 6.3.2. We have been informed that the money we were overcharged for our technology fees will be reimbursed back to us by the end of the fiscal year.
- 6.3.3. Due to growing health concerns about COVID-19 and uncertainties about travel, students who received either the Ray or the CDG in funding periods 3 and 4 will be eligible to use their funds anytime in the next 12 months, even for a different activity than what they wrote their application on.

6.4. Secretary (Light.109)

- 6.4.1. The application window for the Global Gateway Grant has been extended to Friday, March 13th. If you are able and willing to judge applications in the second half of March, please get in touch.
- 6.4.2. CGS will be hosting an awards ceremony on Monday, April 13th from 5-7pm in the Performance Hall of the Union. This event will recognize all winners of the Ray, Career Development Grant, and the Global Gateway Grant over the past year. Additionally, we will be thanking all current delegates, senators, and officers of CGS for their service this academic year and welcoming students who will be taking over these positions. Finally, we will award several CGS awards to recognize students and faculty who have gone above and beyond both within CGS and in the greater OSU community. All current delegates have been invited to this ceremony and a formal invitation is forthcoming this month.

8. SPECIAL ORDER ITEMS

8.1. Delegate Concerns

- 8.1.1. Lo.208- CGS should try to communicate to the university administration that graduate students might need targeted messaging that addresses their unique needs and schedules when it comes to recommendations and decisions about when/if students should stay off-campus because of COVID-19 health concerns.
 - Shockleymccarthy.2 points out that if you are non-essential, you cannot be required to be on campus. All students are considered non-essential.
 - Anderson.3449 said that her dept sent out an email notifying the students of what the procedures will be in the event that it's necessary to close offices.
 - Deros.28 pointed out that different people are comfortable with different levels of risk so there are options for graduate students who would like to start making accommodations

now rather than when things get much worse?

- Scaltriti.1 points out that there is a potential problem for international students who may not be able to return to their home countries over the summer but are also not allowed to work outside of the university.

I know this is a very stressful time as you try to balance your academic, professional, personal, and social lives. Spending Freeze and Budget Update

As you may know, the university is currently in a state of emergency. Therefore, all non-essential spending has been froze through the end of the fiscal year (June 30, 2020). I am in the process of working with the Business Office to gain a more thorough budget outlook, as some things have not hit the budget that were already dispatched for payment. I have not received an updated 90/91 report since our last meeting, so I am not attaching a new budget report in this report. Additionally during our March meeting you all approved travel to a conference in D.C., that travel is now canceled.

We, along with other student governance leaders, are currently working with the Council on Student Affairs to ensure Student Activity Fee recipients (this includes CGS) are not penalized for excess carryforward this year due to the campus shutdown and spending freeze.

Traditionally, recipients cannot carryforward more than 10% of their budget we are requesting that this be waived this year and all recipients maintain their current budget in addition to any funds guaranteed in FY21.

Delegate Engagement Fund

We are no longer accepting Engagement fund request until August 2020, due to the spending freeze. Once the request window reopens, we will notify all delegates. Additionally, we are working to move this request process completely online to be more efficient and environmentally friendly.

Ray Travel Award

Applicants funded during Funding period IV have all been notified. They will have 12-months after their original deadline to use their grant. **Funding period I (of FY21) has been canceled, due to current and anticipated travel restrictions.**



Current COVID-19 Graduate Student Issues

All CGS events have been cancelled in accordance with the recent federal, state, and university [policy changes](#).

Grading

You may be aware of the recent [grading policy](#) changes CGS Senators and the University Senate approved last week. The change allows for classes to be graded Pass/No Pass without penalty and extends the date of which SP20 incompletes will be due. We are working diligently with the Graduate School to ensure that this policy is extended to graduate students across all colleges and sent a [letter to the Deans](#) outlining our position. This will be further decided in Graduate Council on Wednesday. In addition to grading changes, we are also working to solve issues that may arise with dissertation/thesis defense, licensure hours, or other requirements that may impede one's graduation.

Employment & Hiring

With the recent [announcement](#) of a hiring pause through June 30th, the conversations around creating the positions of a Graduate Ombudsperson or a Director of Graduate/Professional Student Life are suspended. We are continually evaluating how this will affect Graduate Associates, especially for summer positions and international students. Key faculty positions (including those of graduate teaching assistants) starting in summer and fall 2020 and key research positions (including graduate students, post-doctoral researchers and research technicians) starting in fall 2020 are excluded.

Graduate Student Emergency Fund

In response to COVID-19, we have asked the Graduate School if they can hasten the establishment of the recently approved Graduate Student Emergency Fund. Matt Page is working on the request and we hope to provide avenues for direct relief soon.

I hope this message finds you healthy and well. Whether you find yourself still in Columbus or elsewhere, please know that the Ohio State community is still here to support you. I have had the honor of chairing the Graduate Student Affairs committee this academic year and I would like to briefly highlight just some of the things we as a committee tackled:

- Authored **Resolution 1920 AU-003**, a resolution calling for the creation of the position of graduate student ombudsperson at the Ohio State University. This position is expected to be filled by no later than the Spring 2021 semester.
- Co-authored **Resolution 1920 AU-005**, a resolution for the establishment of a Director of Graduate/Professional Student Life within the Office of Student Life at the Ohio State University.
- Held a consistent dialogue with the Office of Administration and Planning to thoroughly vet the Lyft Safe Ride program from the student perspective. We have requested that the Office, in coordination with the BuckeyeLink office, identify the percentage of the graduate student population living within the program's bounds so that we can identify how many graduate students are being well-served by the program on a consistent basis. This request remains outstanding.
- Met with the Office of Institutional Equity to discuss the mandatory, BuckeyeLink-provided "U Got This" training. We administered a student survey about the program and have shared those results with the Office to push forward the dialogue on potential changes moving forward.
- In coordination with the COVID-19 Task Force, as well as Undergraduate Student Government and Inter-Professional Council, we created and administered a graduate student needs assessment so that we can responsibly collect information on student needs during the ongoing pandemic

On one final note, I will be graduating at the conclusion of this spring semester, meaning my time with CGS is nearly up. I am confident that Stephen will choose someone to not only continue the work that we began this academic year, but to expand upon it. It has been inspiring to see how dedicated you all are to your roles and the work that CGS does. I eagerly look forward to following along on your continued accomplishments from afar in the years ahead.

Our committee supported one of our members Tyler Beauregard in submitting and successfully passing a resolution calling upon the university to better identify and provide AEDs throughout campus.

Recently our committee, with the support of DaVonti' Haynes, donated \$2,000 to the Buckeye Pantry which we had previously allocated for the Grad Wellness Expo.

Our committee also remains engaged and focused on providing help/assistance during the ongoing COVID-19 pandemic. I am confident that several of our members would be interested in putting together materials and information that we derive from the Grad Student Needs Assessment form (myself included), that we can ultimately distribute/give to the university."

3. OSU Writing center: We had a meeting with the writing center and are going to have another meeting in the coming days.
4. Office of International Affairs: A few members of the committee are working on this issue.
5. The committee received international student conners related to the Covid19 pandemic, sorted them out, and communicated them to the university administration. These concerns included the following issues:

A. Residency Status:

Many international students graduating this semester are worried about going out of legal status as a result of the COVID19-related delays in the processing of immigration documents. ISC committee requested that first, the university allow graduate students who are facing issues with legal residence and may go out of status to stay enrolled in the Summer 2020 term without paying tuition. Second, we requested that the graduate school extend the deadlines for completing final examinations for Spring graduation (the current deadline is April 17).

B. Emergency Funds Specific to International Students:

As international students do not receive any sorts of federal financial aids that the domestic students have the privilege of, we requested an emergency fund for international students who will be stuck in Columbus.

C. Deferral of the Registration for Coming International Students:

We requested that all the programs let international students admitted for Fall 2020 to enroll in Spring 2021 if needed, without any consequences such as losing their GA/GTA/GRA appointments.

D. Extension of programs (general concern):

We requested an extension of a year in the timeline for Ph.D. students who were due to submit their Ph.D. dissertation in Autumn 2020 or Spring 2021. "
